## The Program

Crime and intelligence analysts and law enforcement investigators traditionally analyze and investigate crimes against persons and property, and, depending upon the nature of the case at hand, seek to identify the linkages between people and organizations involved in organized crime, narcotics trafficking, political corruption, and other such conspiratorial activities. But following the events of September 11, 2001, the analytical function has expanded dramatically—and with the expansion has come a dilemma. Analysts and officers are now being enlisted to help their agencies in the fight against terrorism, yet few have had any training to equip them with the skills needed to determine even the existence of terrorist threats, let alone the ability to provide any meaningful recommendation on how to respond to them.

To be effective in the battle against terror, today's analysts and officers must be specifically trained to deal with new problems involving often previously unknown and shadowy figures whose objectives differ significantly from the traditional criminals we have come to know and understand. They must come to a knowledge of who the terrorists are, the groups and organizations they represent, and the motivations that drive them to commit their acts of mass violence. Moreover—and of vital importance—our analysts and investigators must learn how to identify and interpret the often subtle yet critical clues that indicate the possibility of an impending terrorist action, and be taught the analytical techniques to gather information and produce intelligence that truly enhances Homeland Security efforts.
